- **Late Goal Signals:** A public group offering general information and some real-time predictions from "LGS Fund".
- **LGS Fund:** A private, subscription-based group offering exclusive real-time predictions.

- **Cancellation:** You may cancel your subscription at any time. Cancellation will be effective at the end of your current billing period. You will not be charged for the subsequent billing period, but you will not receive a refund for the current period. There are no additional fees for cancellation.
